Mays -- Well, if I don't make it I'm going to put a terrible fight.

E -- Be sure and take some signs with you.

Mays -- Well -- Maybe.

E -- Put some up. That'd be the farthest place.

Mays -- Well, I got some made out there. This sign is to be errected in New Jeruselem after the Judgement. And this one is to be errected on the banks of Hell after the Judgement. XEEXEERENEE. You seen them, coming out, them crosses out there.

E -- Yes.

dune Mays -- When a man looks at that, feel himself at the judgement and got his reward, and what's caused him to have it. But Sister Mays thought maybe they might misunderstand it, and she kind of covered it up, you E -- I was wondering. Some are kind of hard to read. Mays -- Yeah E -- How many miles have you travelled in all? Mays -- Oh --E -- ITEXE Would you say about half-way around the world? Mays -- Oh, this here bunch right here in ten years -- is about three times the distance around the earth -- or four -- from sixty to seventy. I've been doing this for fifty-two year, and Lord have mercy, I've made mileage _ to go around the earth ten times I guess. enough E -- How many signs have you put out in all? And he'll say, "Well, I've got see the deacon board first. I'm not allowed to do that. ax you see." Well he ain't. Well, the deacon board maybe will meet in two weeks. Well, I can't wait. So there you are, you're just. You just can't do that. So I just get to put a sign up ghen I can get it up. Oh, I've put a unxxx bunch up here in Virginia, Just that very way. And I lost come of them before I even got back. I put one up at a church house. . Now I give you this for a sample. I put one up and when I pretty come back, I was checking on it. Didn't ask nobody, just put it/close to the church . And when I come back, why that sign was pulled up and

E -- Well, maybe that's better than most people who don't have much

Mays -- If you have everything easy, you just get to where you're not worth anything -- your business. For a sample, I was up here at Raleigh. Burham Airfield last week. I put a sign up there at that air field. Well, I got down to the west end approach. Well, then there's a farmhouse. I was too far anyway, but I was series try to put in there anyway, and I told her what I was soing -- the lady -- And she said, "Now, that racket has been areasathereristierers in here before." Id had a sign pretty close to there, reason field out, and I had to there is the there is a farmfield out, and I had to there is a there.

for years you know, up till they lengthened the field out, and and had to tear it down. Well, she just kept on, kept on "Racket, racket!" I said, "Now, listen. Now this is not a racket. Now, I'm a telling you know and I mean this. For the good of man. Well, she just went just against good as to say up right then. She said "You betwer get yourself away from here right now. Well, I did. And I went down to the -- out and down to the east approach and found the best place that ever I put a sign since I been putting signs around the airfields. E -- Why did she think it was a racket?

Mays -- Well, you know how people are. I don't know.

E -- Well, at some of the revivals I go to, I think some of them are rackets. I won't go to the ones where they advertise in the paper and take up a big collection and the one man down in Knoxville was habing people raised from the dead. They always happened to be his relatives. He used the same casket, had them come in pretend to be dead, and get a lot of money. They can be a racket.

Mays -- Anything that's right in the middle of the road, I'm right in for it. Now listen to this little thing right up here. There're several preachers around here, well, a few, that's teaching things that disturbs the people, that ain't a doing good. Well, when it comes my privilege, I'll have em to come over here. Now come over here, brother, Come in here. Now listen, you sit down here. I'm goinna do the balking till I get through. You're doing things that's tearing the country up. Now you're my friend and you're my neighbor, and I want to help you, but you just have to stand at attention now till I get through. I just lay it out thata way. There's men a doing that that sin't a doing no good. They're tearing up folks. For a sample, now, there's one man in this city -- that he couldn't preach no time nor no where -- he couldn't say howdy doody without his saying that there's just one in the Godhead -- Jesus only. Well, what do we care, whether there's one or ten, just so there is. See? But he'll stress that and he hurts people's feelings and he tears them all up. Well, if he'd say something else and get folks saved, he'd be worth more. That's the verything I'm talking about, right there. I know him well. He's a good man, too. So I'm gonna get him in here one of these days and tell him you ought to say something else besides just that cause you're just causing confusion. You might not think it, but I know it () I might help thatta way, maybe some. It won't worst him I know that for sure

E -- Are you Church of God?

Mays --- No, I've done all my work interdenominational. My wife belongs to the church. I'm doing it all interdenomination. There's three --two hundred and fifty-nine chartered churches in the United States --

tenter besides the ones that don't have a charter. And I'm a friend of all of em. I'm just working through all of em. Any man who just looks ain't lookin like he wants to live right, I'm. And them that just destinated noway, I want to help them, too. So there you are.

E -- The papers I was showing you in the other room -- I had to write down what a revival means and what what preaching means and what faith healing and -- a lot of people never heard of these things and I was trying to write them down. And of course I go to any revival. And I had to write it so that it would mean -- thrr so that it would be kind of right for -- you know, if it was Holiness Church of God or Baptist. And at the show down here in Knoxville, some of the people were saying. "Oh. our revivals are seven days and I'd written down ten. Others would say, Well, we don't have faith healing." Well, you have to kind of get what mostly happens and somebody's going to take exception to anytying you write down. They get awfully upset about it. Some of the people from, let me think now, it wasn't Holiness church, it was Holy Ghost People on Middlebrook Pike. Now this film we're showing with the exhibit is called Holy Ghost People. Now they're up in Sorabble Creek, West Virginia. And they have snakes. Well, the people on Middlebrook Pike were furious cause they said they didn't have snakes But West Virginia's different. All you can do is just just anymore. show what it's like different places and hit a little bit of every church. Mays -- When you're fooling with the public, now that's it. But the only thing just common people to do real good and just take the go between, that's all you can do and make the best of it. It'd surprise

you what I run into out on the highway. Well, it's just got so you don't ask nobody to put a sign up. . . . The state won't let you. Individuals

won't let you for different reasons. They've been bothered to death for years and years and --E -- But if you just go ahead znd put on up, is it likely to stay there? Mays -- Well, it's just more likely to stay there than if I asked. Here's what happened. I put thirty. Let me see, let me get this book.

out.

E -- Let me see. You're just back from a North Carolina trip.

Mays -- Yeah.

E -- Now what did they say about it?

Mays -- Oh, ixignitukenexx I didn't ask them.

E -- Now how long are those like to stay there?

Mays -- Longer than they would if I'd asked. If i'd asked, I'd never gotten none up.

E -- But like if you go back next year.

Mays -- I'll miss some of them. Yes. Now right there's the trip I made to North Carolina. Well, these big ones is the ones that got on the Interstate. The others is the small ones. I didn't ask noplace to put them. Nobody . except this air sign that I put Minder Raleigh Durham airfield, because you don't have to get no 660 feet from the fence in North and South Carolina. But you do in Kentucky. When you get 660 feet away from a fence, you better be asking somebody when you put one of those big ones up. That's what I done. But narry a one of these did I ask.

E -- Those concrete ones, they weight what 2200 pounds?

Mays -- 1400 pounds, yes.

E -- Now, can you do that by yourself?

Mays -- Oh yeah, me and the driver can put them up. Now here's the ones

- I put up a month ago in Chicago -- I mean up to Detroit and over to Cleveland and back down. Now thesese --

E -- Is that Akron and wheeling -- Freeport.

Mays -- Now here's where the big ones went. Now I had to ask. I put up 500 dollars worth of **anarhymrightmare** energy right there getting permission to put them five up. That at one and this one.

E -- And do the big ones do more good than the little ones? Mays -- no, well, yes. The masses of traffic is on the interstate. And I've been laying off of them up until last year. And I've got to begin

on that. Now here's what I do. For a sample next year I intend to go A California. I'll get on this interstate here. And on them highways that crosses, I'll run up and put on, a small one.

E -- So the big ones will go on the Interstates, and the small ones --Mays -- Oh yeah, the small ones -- cause if you've got to get 660 feet from the most -- well, this here right here, this state, all around through here, even Texas and Las Vegas and Arizona, you just have to get across the fence. But all those up in here, just about every one of em, you've got to get 660 feet from the fence on the Interstate. E -- You have to do a lot of studying the laws of each state you do into.

Mays -- Well, you've got to know what you're doing. I've got there at the back, there practically all the states, rules and regulations on

them.

E - You've got a pile of things here.

Mays --mYou've just simply got to know what you're doing, or you're just losing all your signs.

E -- Now those bottles that you put in -- do you have to get permission to put the bottles out?

Mays -- You mean the whiskey bottles? No. Now, I was over to Wright

Field, carolina Beach and Myrtle Beach this time. Just walk right on them big old things right out there, where they fish out there, then take me a gang out and just throw them out, you know.

E -- And then they just start drifting around?

Mays -- Oh yeah.

E -- Do you -- In the bottles that you have there, did you ask them to call you?

Mays -- Yeah, it's a -- whereever they find it, set and write me a card so I can tell where it's went to, you see. For a sample, I put some in at Long Island, New York some time back. Six months later, I got a letter from one of them in the English Channel in England. See? Well, that's bound to have got in the Gulf Stream. That's a long way just to leave a bottle, you know. Fraixx Six months.

E -- How many languages is it written in?

Mays -- Fourteen. Hand me one of them, honey, one of them bottles there, and I'll show you. Well, that's the way she works right there. E -- I see.

Mays --- Now I didn't ask nobody about these small ones, but I did ask permission on these. But on all these states that you don't have to, I just get up to the exit and I come down Farmer Brown's road there. That belongs to the county. In other words, where the Interstate is there's a little road there that belongs to the county. Nobody cares about it. I get right up there and put it up without asking. Now this language right here at the top. Now that's the way they speell PREPARE TO MEET GOD IN TURKEY., Indonesia, Spanish, Russian, African, English, Chinese, Syrian, Jewish and Japanese.

E -- What language is that?

Mays -- That's Italian. Gesu Viene Sobitto. Now, sometimes I use them this Budi Gotov Vstretit Boga. That's Prepare to Meet God in The Russian language.

E -- How did you get it in all the languages?

Mays -- Well, I had the University of Tennessee to translate a lot of it.
And then I run into some -- well for a sample.
this Syrian. Thisx A syrian down here run a store down here, and I
got him to translate. In other words, most of it, the University of
Tennessee translated. I wanted it exactly right, because if you don't

expecially in this -- one little bitty old curly-gig each change the
meaning, they tell me, of that -- I call it chicken scratching, I do.
That's what it looks like to me.
B -- Yeah, and it would make a big difference. It would be like like
making a mistake in our words.
Mays -- That's what they tell me. Just one little twist around there make
a difference. -- change the meaning or not make it mean anything.

E -- When did you start doing this?.

Mays -- Fifty-two year ago -- Oh, throwing these bottles in, O've been at it about fifteen, about fifteen years.

E -- But the roadsigns. How did you start. Was somebody else doing it before you were? Or were you the first one to think of it? Mays -- That's the first I knowed of it. I used to just get me a tablet and write it on a -- You know we didn't have much money back then, and there wasn't none to get, much -- fifty-two years ago. I'd just get me a tablet and write out whatever I wanted to and tack it on a telephone pole and kept coming on up **HENEX** till I've got it to hurtin now ??????? All these out of alumium.

TERRETARE MANY feet long? That big one -- twenty-four feet long? Mays -- Forty-eight.

E -- Forty eight.

Mays -- These I put around these airfields is two hundred foot. Eight foot by eight foot letters. And I'm a making them a little smaller than that now.

E -- You make them all yourself?

Mays -- Oh, I make them all. Yeah.

E -- You cast the concrete and.

Mays -- Xxx Well, yeah I make all these signs. I'll show em to you back there. You ain't rushed for time, are you?

E -- No. I'm fine. I'm just -- Curious as to what how you made it and what gave you the idea in the first place.

Mays -- Well, it's just like a man preaching. He gets converted, and -- maybe you don't feel like you ought to say it -- testifies. First thing you know. It's puts them over the first time. Stage frights them, you know. First thing you know, he's talking a little bit. Next thing you know you couldn't stop him with a maul. You could't stop brother Roger Powell with nothin. Now he'll preach or bust . . . and that's the way it is. The only wan the would stop me from putting up signs is to cut my throat, that's all.

E -- You mean people get mad about this.

Mays -- Yeah, Lord have mercy. Now let me tell you this for a sample. This sign right there. It's on Interstate -- it's either this one or this one. in Ohio. That's the one right there. Right there.

E -- Between Canton and Cambridge?

Mays -- And Akron. Right there. You know what I had to do? I had to make a man think that I was positively having a heart attack to texas get him to let that sign stay there. Now you wouldn't think that. Now what happened -- I went up and got permission to put it. And paid It was a pretty good piece down there to where we had to take him. that sign down. And he said, " now you'uns go on the first side of that It won't hurt nothin. and grass over there, and drive your truck down there so you won't have to carry that sign so far. Well, we got down there. And it started raining. And when we unloaded that sign, I told my buddy. I said, now, buddy, you'd better take this truck maxbaxx back up ther to the road. We'll have a pull job if we don't watch. And right where he parked that truck up there, the man that owned the place, his chain was a laying there. Well, my buddy thought it was my chain -- it had fell out of the truck -- and he brought it back down there and put it in the box. Well, I didn't know the difference. Well, we got that sign up in the rain. It's was araining, and I had rain shoes on and a gum doat It was burning up. And I can't hardly walk on that ankle nohow. -- I've got arthritis. And we got all our tools back over there ready to load them back up. He come down there just as mad as he could be. He reached

right down there in that tool box and drawed that chain water up and said. "What'd you'uns think you're doing?" Well, I said, "Man, whatare you talking about? " "Well, this is my chain and it was right in your box here: You're going to carry it away from here." I said, now brother. rHerr I don't know nothin about that chain." My buddy spoke up and said, "I thought it was Harrison's chain that fell out of that truck. "No. you didn't. You's gonna take that chain." Now, the longer he talked, the madder he got. I never have seen a madder man except one in my life. And he said, "You'uns go down there and take that sign Get it away from here right now before you steal everything I ve down. Looking right at me. I said, Brother, ain't no way in the world got. or anything. of my apologizing, or paying you? I've not got the strength in me to take that sign down now, til I rest a while." He said, "You just wait till you rest a while, and go get it. Get it out of here. I would 'nt have it on my place at all, dirty fellows like you'uns." Well, I said to myself, "I'll just make him think that I'm having aheart attack. I didn't feel good nohow. And that ground waz just as wet as it bould be. I just said, "Bud, you'll have to wait till I get to feeling better. I couldn't take it down to save my neck. I just laid right down on that ground, wet ground, turned over on my tummy, and I said, "You'll have to wait a while. I heered him tell my buddy, "Well, I'd better not say anymore to him. I'm liable to cause him to have a heart attack. That acts like what he's having now." Well. I knowed right then it was And that's working. And I just left it that way. Itrume the only way in the world I could appease his anger, I'll tell you . . .

E -- Did he care that much about the chain? Did the chain matter that much to him? Mays -- No, it was just a matter of, he thought it was stolen -- that we's stealin it. My buddy was honest. I didn't know nothin about it.

He thought we were stealing it. No -- well it was a pretty good chain just like it. But I went limping over there at the truck. I got -- when I had one. we got through, I told my buddy to carry the tools over there and I'd be there in a little bit, and I got that little post and went walking over like I couldn't hardly stand up nohow. I wasn't feeling good, but I was a putting it on good. I was afraid he'd say, "I believe you're feeling SHE better. Just go get 1t. That's the way morks. Man up in New York, he had a forty-five hanging right out here. I way up on the truck getting the sign off and my buddy was digging the hole, and he was talking to my buddy over there. and he said, "Over there's the man that's doing it. And I went over there. And he said, "What do you think you'uns a doing?" I said well, I thought we'd put a sign up here." "Don't you thinkxxx know you'll get shot? " Well, I could do it. I was looking right at the maddest man I'd ever seed. This one's the second one. And I said I'll just not put it up here. well, I just won't put it up. "No sir, you're not going to put it up mere He said, "Get that sign out of here. Fill that hole back up and get awy from here. Well, I hadn't got the sign off the truck yet. And I could have said, "Listen, buddy, you don't own the right of way. That on the right of way. But I would have got shot sure enough, man that The only way you can do, if a man rolls up on you -- he's got ' mad. only five minutes to catch me. Cause I'm a putting that sign together right there at the truck. My buddy's a digging the hole up there. State man come along, and he thinks Farmer Brown's putting something up up there. Farmer Brown come along, he'll think the state's a putting something up there. When I get that hole dug and that sign together, then I bring it right up there and stick it down in that hole, and he's got five minutes to main catch me. I'm gone. If he catches me, I've got to do something about 1t. Pay him, apologize, or take it down.

May -- Yer Oh Yeah. I'll say I'd lose -- I'm making ten per cent to I'll not lose. xixmemit lose over ten percent in a year. If I get a sign on a highway, and it stays a week, I've got value received out of it. Thousand upon thousand -- it'd surprise you how many people read it. E -- Well if they leave it, is it because they decide they like it or it's too much trouble, or they don't notice it, or --Mays -- Well, a -- Well, I got a letter from Columbus right there. I got a letter from this section right in there, the other day and I answered it yesterday

E -- These signs are really interesting. Sacred signs in fifty states 82 nations, seven seas and all the big rivers and lakes in America. Mays -- They're on the right-of-way. Well, I knowed that. You see, there was five of them. And he told me right where they's at. Well, I know they're on the right of way because I can't do nothing else. I get them just as near the right of way as I can get. So that's the size of it, right there. **XTHEXX** Now that man -- that's in this section right around here, right around this columbus, he's just predudiced against something sacred. That's it. Lot of state men moves them back and so on.

E -- Well, it's kind of mice letter. It's. not being mean about. He's just say9ng it's going to get taken down.

Mays -- No, he just a doing his duty.

E -- He's not threatening to fine you or anything like that.

Mays -- He's doing his duty. I'm a doing mine. And what we got to do is to work it out. No, he's a nice man.

E -- Will the highway department usually leave them up if no one complains Mays -- More less, yes, if they can. But . . . If someboey objects. We get to take care of their job. Now that's the size of it. Now they've got to take care of their job. Now that's the size of it. If the pressure's put on this man, he has to move them. I where it

And I told him what to do with it. Leave them stay there till long as possible, or till I can pick them up. Well, I'm not picking them up -- I'm being back in five years, but he don't know that. I I said. "Leave them as long as you can or till I can didn't say that. pick them up. And if you have to take them down, before I czn pick them up, why you have Farmer Brown to set it back, just a foot. They'te all within a foot of the Right-of-way. Set it back, just on Farmer Brown's place and send me a bill for five dollars for just setting it back. Or get some man that's retired and wants to make him twehty-five dollars, for setting them five back, why, just set them back and send me a bill. and I'll send him twenty-five dollars, or if you have to take them up, why take them down to the state garage where you're gonna put them for me to pick up in thirty days -- after thirty days -- and set them up there where people can read them. They'll do that. They'll help you out. I say, "Help me any way you can because it cost me too much money. Them cost me thirty-three dollars aniece. A thousand dollars is what truckload of signs cost me. Two thousand dollars for these two truckloads and now this next one acoming up, I'll show you. is another thousand dollars -- three thousand dollars this year.

E -- Whare does it come from?

Mays -- I make it I'm a sign painter, you know

E -- But the materials and all that. That must cost a lot. Mays -- Well, it's all alumium. Sure does. And they sure don't give you that stuff, I'm a tellin you. I do all this -- Giles industries up here that makes all these trailers -- I do all their truck painting and take aluminum instead. And they give me a reduction -- in other words twenty-five cents a square foot form 's what that alumium cost,

but they let me have it at fifteen cents. When I paint a truck for them, or one of them tractors, they'd pay thiirty-five or forty dollars for each one of them. I do the job for fifteen. I dan do it in a hour and fifteeners ten minutes. That's pretty good money -- an hour and fifteen minutes, fifteen dollars. A lot of days a make forty and fifty dollars. Some days I have -- a couple of days -- made a hundred dollars. But now I don't do that all the time. The Lord's running this machine, and when I need money, I can make it just as easy. I paint all the cocca-cola signs, the RC Cola signs and Giles up here and a lot of the folks around here. It takes a lot of money to carry max on. I don't need memory. See, I'm retired on Social Security and pension, miners pension. Me and my wife can live on that. All I make I put it into the work of the Lord, all of it.

E -- Oh, that's right, Rev. Powell said youwere in the mines.

Mays -- Yeah, forty-three years I worked in the mines.

E -- Are the mines still open around here?

1

Mays -- No, they closed down in fifty-five -- where I used to work. See, I draw a miner's pension. That's a hundred and fifty dollars a month. And Social Security, Me and Sister Mays draws a little over three hundred dollars a month. We don't owe nobedy or nothing. Maintagetr We got our pwn place to live, Now we can live on that. That gives me and her a chance just to work for the Lord. She goes to church all the time. And I go on the highways all the time.

E --- Your house is almost a church. You built the whole thing yourself Mays -- Oh yeah, made the blocks even. -- everything.

E -- I wish I could see it from here -- the shape of a cross is an unusual shape for a house.

Mays -- Oh, they ain't nary another'n like it in the world, I don't recken E -- I've seen churches in shapes of crosses, but never a house. Mays -- Yeah. Now, I don't guess there's another house, anywhere. In the world E -- Did you grow up imme here in Middlesboro? Mays -- I lived right max up here in this hollow here ever since I was about six mears old. I was bern over here in Claiborn county. Term but my dan moved to the mines up here in Mingo Hollow when I was about six years old.

Mays -- Yeah. I've been right here all my life. Right here in this area. Worked forty-three years we right up there at one mine -- Spark Ridge. About seven miles up there. All my working life. But they shut down in fifty-five. Then I had to go to -- Well, I've been painting and years. religious signs for years. And then I just had to go to painting signs for a living cause when you get -- oh, so old as I was then, you can't hardly get a job nowhere Especially in the mines because you're out. And I had -- they's a period right there where I had to wait b etween the time the mines shut down and I I got elegivle for the pension, that I tell you I had it hard.now, that's all there is to it, trying to make a living and keep this work going, too.

E -- You're a good sign painter.

Mays -- Well, this right here behind you here. Now that's a contrast between good and evil. See this right under here, you see these Bibles, song books, testaments, things you take the sacrement in, the bread and -there's my little shurch house up here and everyinything on this shelf up here, a little bit of Heaven. And everyinything on this shelf, that's a slot machine you're looking at right there. And this is actual whiskey you're looking at right here. E -= Cigars, cigarettes.

Mays -- Everything I can think of that's evil, I --

E -- Cigars and cigarettes.

Mays -- Oh, yeah, well, that's kind of less -- lightly -- Oh, that's not bac. . . . I just got that in there kindly -- it ain't good anyway. Pistols. That's my aunt's pistol there, it's about seventy-five years old. That's an antique sure enough.

E -- That slot machine's an antique, too.

Mays -- Yeah, I've had it twenty-five years. Man give it to me down here twenty-five years ago. Down here at the drug store. Now everything in the world that's good, that I can get a held of, goes up there. Everything that I can get a held of that evil goes **downxthere** right thee. E -- That one in the middle's home brew.

Mays --- Yeah. It froze and busted down there. That canned heat, I believe one of them bottles froze and busted. Now in this thing right here -- I've got them closed in there because the children's in here, and in that box over yonder is everything in this world pertaining to nudistry. is in these. Now it would surprise you how much Satan -- how big Satan's got in them things.

E -- Oh, they're books. I see. It's kind of hard to see. Mays -- I've got them in that box there. And then this thing right here. E -- Oh those are magazines.

Mays -- Books and magazines. See for a sample right here's some of the. There's some of the nuddist colonies -- where they're all at and in there all them packages that tell you where they're at. How they're progressing and where it's at. I know where they're all at all over the earth. E -- Did you ever put a sign up at a nuddist colony? Mays -- Oh, yeah, I've put em.
